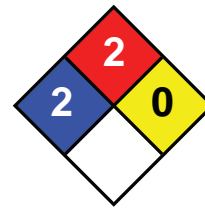

## 4. FIRST AID MEASURES

First Aid:	<p><b>Ingestion:</b> DO NOT INDUCE VOMITING. Contact nearest Poison Control Center for assistance and instructions. Seek immediate medical attention. If vomiting occurs spontaneously, keep victim's head lowered (forward) to reduce the risk of aspiration.</p> <p><b>Eyes:</b> If product gets in eyes, flush eyes thoroughly with large amounts of water for at least 15 minutes, holding eyelid(s) open to ensure complete flushing. If the eyes or face become swollen during or following use, consult a physician or emergency room immediately.</p> <p><b>Skin:</b> Remove contaminated clothing and wash affected areas with soap and water. If discomfort or a skin reaction occurs, contact a physician. Do not wear contaminated clothing until cleaned.</p> <p><b>Inhalation:</b> Remove victim to fresh air at once. ## 5. FIREFIGHTING MEASURES

Pay attention to the spreading of gases especially at ground level (heavier than air) and to the direction of the wind. ## 7. HANDLING & STORAGE INFORMATION

Work and Hygiene Practices:	Avoid breathing vapors. Avoid eye and skin contact. Wear protective equipment when handling product. Keep out of the reach of children.
